Competition Agreement

Registration Deadline:

Registration due date is 10 days (post marked) prior to event. After this date, a late fee of \$75.00 will be charged. Payments received after each due date will cause the team to pay a late fee of \$75.00 per team. **NO EXCEPTIONS MADE!** Late fees are due on or before each competition. All fees and dues not received may cause your team to be disqualified from the Competition. No, refunds are rewarded for any reason.

Cancellation Policy

Registration fees are non-refundable. If a sponsor does not reply/declines within two weeks of the signed date you are obligated to participate. All cancellation should be in writing. Phone calls are not accepted. Once the sponsor did not decline he/she will be held liable for the team and number of participants entered.

Cheer/Dance Routines and Battle Routines:

Routines must be appropriate for family viewing. Any vulgar/suggestive movements, words, music, tear away or removal of clothing may result in a penalty. If you are not sure about your routine's content or music you have chosen, please call us.

***Must have 2 copies of music – one for DJ and one with Coach (or Sponsor) as a backup.**

Music must be LABELED and on CD or USB, NO CELL PHONES

Sportsmanship:

SSAP, LLC. will not tolerate any displays of poor sportsmanship from any team or organization. Any advisor, coach, administrator, student, or parent demonstrating poor sportsmanlike conduct will cause the team to be penalized. The team may also be asked to leave the competition. The team and/or contestants will forfeit all awards and will not be given a refund of any kind.

Food:

Outside food and/or drink is **NOT** allowed, including ice chests. Any person(s) breaking the rules will be asked to discard their food and/or drink or to leave the premises.
