EVENT OVERVIEW

Event: SSAP PEE WEE PRO BOWL GAME NORTH VS SOUTH

Group: Youth Football League Best of the Best Players

Event Date: December 7, 2024

Venue: TBA, Houston Texas

Objective:

The SSAP Pee Wee Pro Bowl is a game that brings together the "best of the best" the best players from youth football leagues around the country. They are nominated, then voted on by the selected pro bowl coaches. These elite players will go head-tohead in a football game to recognize their hard work and achievements - those outstanding credentials from the 2024 football season.

*Divisions:

Ages 4 – 6 players (Flag)	Ages 7 – 8 players
Ages 9 – 10 players	Ages 11-12 players

*Players are <u>eligible</u> to participate in the division in which they played during the 2024 season and received their "pro-bowl" credentials, regardless of age.

Players are selected for the Pro Bowl based on their credentials – their stats of the season. Flag teams will play 2 halves with a running clock and a 5-minute halftime. There will be NO kick-offs for flag teams. Game will start at the 50-yard line. All other Pro Bowl division games will be 4 full quarters with a regular 10-minute halftime. There will be **NO** spearing, helmet-tohelmet hitting, chop blocking, and cutting at the knees...Just "good ole" basic tackling.

In case of a game tie, the sudden death rule will be utilized. Each team will begin on the 20yard line and have 4 downs. Each team will have a chance to score. If one team does not score, then the team that does score will win the game.

Coaches will have one (1) week, Monday through Thursday, to practice with their team of talented players.

RULES AND PROCEDURES

Security:

Youth Football League policies will be in place on premises beginning first at each practice at each site until Saturday. Then, on the day of the Pro Bowl, police officers will be on hand.

Parents of players will be given a pass <u>only</u> to watch practices on Monday through Thursday.

Passes will NOT be given for Pro Bowl Game

Equipment:

- 1. All players must represent *their* organization by wearing the team's helmet (please have logo visible and clear!)
- 2. All players must have their own cleats, shorts, under armor, shoulder pads and jocks.
- 3. SSAP will provide players with their gameday jersey, pants and socks. All SSAP equipment will be collected directly at the end of the game.
- 4. All coaches will be responsible for providing players with water or Gatorade during the week of practice.
- 5. Players will be able to wear any practice gear during practice.

Transportation:

- 1. Parents of the North Team are responsible for bringing their player(s) to the designated field for practice.
- 2. Parents of the South Team are responsible for bringing their player(s) to the designated field for practice.
- For North Team players only a charter bus or van(s) will be provided to bring players to Houston to the hotel designated for players to stay the night before Saturday's Pro Bowl game. There is a \$25.00 fee to ride.
- 4. Players for North teams will stay Friday night only and must be prepared to check out Saturday morning **before leaving for the game**.
- 5. All coaches will be responsible, along with directors to make sure all players are checked in and out of the hotel by 8:00 am.

Registration:

To get into the selection pool, all potential players must complete the **Player Registration Form** and **include a \$20.00 registration fee**. This fee covers the cost for verifying the player's credentials through the league and the inclusion in the **Pro Bowl Program booklet**.
